

TERMS AND CONDITIONS

§1

GENERAL PROVISIONS

1. These Terms and Conditions define the rights and obligations of authors who wish to publish their abstract in the *Abstract Book*.
2. The aim of the *Abstract Book* is to place the abstracts of scientific articles and descriptions of works presented during the **5th Scientific Conference "Energy Security - Pillars and Development Perspective"** in one place.
3. *The Abstract Book* is an electronic publication.
4. The material will be published simultaneously in **Polish** and **English** with a division into thematic areas.
5. The subject of the message with the attached file should be created according to the template: thematic scope_theme of abstract_name surname (e.g. CLIMATE POLICY_CO2 Emission in Slovakia_Adam_Nowak).
6. The abstracts will be accepted **no later** than **30th June 2020**, only to the following e-mail address: konferencja@instytutpe.pl.

§2

THE CONDITIONS OF PUBLICATION

1. The maximum number of abstract authors is **three**.
2. One person may be the author or co-author of **up to two abstracts**.
3. The volume of an abstract may not exceed **3500 characters for each language version**.
4. The abstract must be written in accordance with the editorial requirements contained in the file: *Abstract_editorial requirements*.
5. File *Abstract format* is a formatted document in which authors should create their material in accordance with accepted requirements.
6. The authors are obliged to write a version English according to the presented template (file *Abstract format*) with full translation of affiliations, academic and professional titles.
7. The authors are obliged to assign their subject matter to one of the five thematic areas:
 - a) energy security
 - b) energy policy
 - c) energy resources
 - d) renewable energy sources
 - e) transformation of the energy sector
 - f) other (insert as appropriate)

§3

FINAL PROVISIONS

1. Abstracts sent after the deadline will not be published in the *Abstract Book*.
2. Abstracts inconsistent with editorial requirements will be returned to the authors in order to correct them in accordance with the adopted requirements.
3. The *Abstract Book* will be divided into thematic areas according to the conference panels.
4. The Organisers undertake to send information to the authors about the publication of the Book of Abstracts.
5. In accordance with the Personal Data Protection Act of 29 August 1997 (Journal of Acts 133 of 29 October 1997, item 833.), the Editorial Office does not transfer, sell or lend the collected personal data of the authors to other persons or institutions. Personal data provided by the author are treated as confidential information and serve only for the purposes of communication between the author and the Editorial Office of the Book of Abstracts.

§4

PROTECTION OF PERSONAL DATA

1. By registering my participation in the **5th Scientific Conference „Energy Security - Pillars and Development Perspective”**, which will take place on 12-13 October 2020 in Rzeszów, I provide my personal data, which will be used only for the purposes of organizing the conference, as well as for publishing and marketing purposes, closely related to the Conference and I. Łukasiewicz Institute of Energy Policy's privacy policy (<http://www.instytutpe.pl/polityka-prywatnosci>). Providing the data is voluntary, but without it it will not be possible to send organizational information. Data processing is based on the consent referred to in Article 6(1)(a) of Regulation (EU) No 2016/679 of the European Parliament and of the Council of 27 April 2016.
