

Terms and Conditions of the Competition for the Best Scientific Poster
5th Scientific Conference
„Energy Security – Pillars and Development Perspective”
12-13 October 2020

§1 Definitions

1. Organizer of the Competition for the Best Scientific Poster is the Ignacy Lukaszewicz Energy Policy Institute in cooperation with the Ignacy Lukaszewicz Rzeszów University of Technology. The role of the coordinator for the implementation of tasks related to the organization of the Competition is played by the Ignacy Lukaszewicz Institute of Energy Policy. The co-organizers are: Department of Economics of the Faculty of Management of the I. Lukaszewicz University of Technology in Rzeszów and the "Eurointegration" Students Scientific Circle.
2. Scientific Poster Session - an event related to the public presentation of scientific posters, which will take place on 13th October 2020 at the Rzeszów University of Technology as part of the 5th Scientific Conference „Energy Security – Pillars and Development Perspective”.
3. Competition - Competition for the Best Scientific Poster at the 4th Scientific Conference „Energy Security – Pillars and Development Perspective”.
4. Participant - each author/co-author of a Scientific Poster issued for the 5th Scientific Conference „Energy Security – Pillars and Development Perspective”, who will express the willingness to participate in the Competition for the Best Scientific Poster by sending a poster (taking into account all formal requirements established by the Organizer).
5. Conference – 5th Scientific Conference „Energy Security – Pillars and Development Perspective”, which will be held on 12-13 October 2020 at the Rzeszów University of Technology.

§2 General Provisions

1. Sending the application form for participation in the conference is tantamount to acceptance of these regulations.
2. The organizer reserves the right to change the provisions of the regulations. In the case described above, the organiser undertakes to inform the Participants about this fact.
3. Posters must be original in accordance with the provisions of the Copyright and Related Rights Act.
4. Submitting the application is tantamount to agreeing to place an electronic version of a scientific poster on Facebook and the Conference website.
5. The authors of posters have the right to have published a description of their works in the book of abstracts as well as to submit a scientific article to the journals: *Energy Policy Studies* and *Modern Management Review*. In case of strong interest, the organisers may consider publishing of scientific articles in an e-book or in other scientific journals, which cooperate with the 5th Scientific Conference „Energy Security – Pillars and Development Perspective” (after prior consultation and on condition of obtaining positive reviews).
6. The Organizing Committee of the Conference is responsible for the proper proceeding of the competition.

7. The organisers have the right to reject any scientific poster on the basis of a preliminary assessment made by selected members of the Scientific Committee of the Conference.
8. All questions, comments, reservations should be submitted to the Organizing Committee of the Conference via e-mail: konferencja@instytutpe.pl.

§3 Participants/Application

1. Participants of the Competitions are all authors / co-authors of Scientific Posters, who expressed their willingness to participate in the Competition by sending a complete application (thus registering their participation in the Conference) and a poster (taking into account all formal requirements specified by the Organizer) within the set deadline. The maximum number of co-authors is 3 persons.
2. The application should be made by sending an electronic version of the poster to the address konferencja@instytutpe.pl with information about the authors (including affiliation) together with a scan of signed Attachment No. 1 to these Terms and Conditions within the deadline resulting from §5 of these Terms.
3. The electronic version of the poster should be saved in JPEG format (sRGB). The file should not exceed 5MB. Organizers reserve the right to modify the file (size/resolution/format) in case of problems with editing it or placing it on the portal.
4. The organizer does not take responsibility for the quality of the published photo, however, it should be remembered that the quality of the photo affects its reception and subsequent evaluation.

§5 Schedule

5th October 2020 until 23:59 – the deadline for sending an electronic version of scientific posters to the organisers to the following e-mail address: konferencja@instytutpe.pl with information about authors/affiliations. Failure to deliver the electronic version of the poster within the specified deadline will result in the exclusion of the participant from the competition.

12th - 13th October 2020 – poster sessions. The exact times of the poster sessions, during which the presentation and evaluation of the poster will take place, will be given on 1 September 2020 together with the final Conference Programme.

13th October 2020 – the results of the vote will be announced during the Scientific Poster Session (12:15-12:45). The Organizer reserves the right to change the time of announcing the results, if the program of the Conference is changed. At the same time, the organizer undertakes to immediately inform the participants, if such an exchange takes place.

§6 Rules of the Competition

1. Participants have to send the electronic versions of the scientific posters to organizers in accordance with the provisions of the Regulation.
2. Participants have to deliver their scientific posters to registration on the first day of the Conference. If there are any difficulties that make it impossible to deliver the scientific posters on time, participants are obliged to contact the Organizing Committee at least 2 days before the Conference begins.
3. Organizers will hang the printed posters in the room where Poster Sessions will take place on 12th and 13th of October 2020. The exact hours of the Poster Sessions, where the presentation and assessment of them will take place will be released on the 1st of September 2020 with the final Conference Program.
4. The assessment of the scientific posters will be made by the Scientific Committee chosen by the Organizers.
5. The main criteria according to which the assessment will be proceeded:
 - a) Content and the substantive value,
 - b) Originality,
 - c) Methodology,
 - d) The way of presenting the subject.
6. The results of the Scientific Posters Competition will be announced on the second day of the Conference, 13th October 2020. The awards will also be handed out on that day. The Author/Authors of the best one, according to Scientific Committee's assessment, will be awarded.
